



Terms and Conditions

The terms and conditions set out in this document are the conditions in which All Stars Limousines will provide its services to you.

1/ Any passengers under the age of 16 must be accompanied by an adult. If there are any passengers under the age of 18 there will be no alcohol available or permitted inside the vehicle under any circumstances. All Stars Limousines reserves the right to request identification of all passengers.

2/ The driver reserves the right to terminate the trip if any passenger refuses to comply with any direction given by the driver of the vehicle. Any abusive, irrational or antisocial behavior will not be tolerated and the driver reserves the right at any time to terminate the trip as a result of such behaviour. In the event of the termination of the trip in accordance with this clause 2, you will forfeit any monies paid to All Stars Limousines and will be further liable for any loss All Stars Limousines may incur, including but not limited to hire fees of any subsequent booking the driver is unable to fulfill as a result of the breach of any of these terms and conditions by any passenger.

3/ Video surveillance operates in the vehicle at all times. Any damage caused by the passengers will be charged to the nominated credit card on the booking form. The party named on the booking form is responsible for the behaviour of all passengers and is liable to All Stars Limousines for any damage caused to the vehicle howsoever occurring and whether occurring inside or outside the vehicle.

4/ All Stars Limousines, its agents, employees and contractors are not liable or responsible for any items of personal property taken into the vehicle and all passengers indemnify and release All Stars Limousines from any such liability. It is your responsibility to advise all other passengers of this clause 4.

5/ At the driver's absolute discretion, the vehicle must not travel to or through a location or situation that may result in serious risk of damage to the vehicle (whether actual or perceived). If reasonably possible in the circumstances, the driver may elect to travel an alternative route to the requested destination to avoid any risk of damage to the vehicle.

6/ To secure a booking a 50% deposit of the total hire cost is required at the time of submitting the booking form. All bookings must be paid for in full at least 60 days before the event. Any booking submitted within 60 days of an event must pay the full amount of the hire fee before the booking will be accepted by All Stars Limousines. Cancellation of a booking must be confirmed in writing at least 60 days before the date of hire. In the event you do not give us this notice of a cancellation you will be charged the full rate of the hire fee. All bookings must provide valid credit card details.

7/ No food or drink is to be brought into the vehicle under any circumstances unless mutually agreed otherwise. The driver will make an exception for medical reasons such as diabetes or life threatening food allergies upon the driver receiving appropriate documentary evidence to that effect. No animals or pets will be allowed into the vehicle with the exception of guide dogs only.



8/ Smoking in the vehicle is prohibited at all times.

9/ All passengers under the age of 18 years in the vehicle are the responsibility of an accompanying adult. It is the accompanying adult's responsibility to ensure any children in their care behave appropriately and in accordance with these terms and conditions generally. Any child under the age of 7 years must only travel in an appropriate approved child restraint seat which must be supplied and fitted by the responsible adult. Three restraint anchor points are provided in the vehicle for this purpose. The responsible adult is liable for all matters concerning the installation and use of the child restraint seat and All Stars Limousines accept no liability under any circumstances for any matter concerning the installation and use of a restraint seat.

10/ In the unlikely event the vehicle breaks down or is involved in an accident rendering the vehicle un-drivable, All Stars Limousines will try to find a replacement vehicle for you to transport all passengers to the required destination. All Stars Limousines may, in its absolute discretion, determine the method of the alternative travel. All Stars Limousines does not guarantee in any way the timing, reliability of the alternative transportation or any other event outside the control of the driver and All Stars Limousines. Any extra costs of providing the alternative transportation will be met by All Stars Limousines however no refunds will be given as these events are out of All Stars Limousines' control.

11/ The driver will use its best endeavours to arrive at your nominated destination in time however due to the unpredictability of traffic no responsibility or liability will be accepted for any loss you or any other passenger may suffer or incur due to late arrival.

12/ You are liable for the full retail cost of any additional cleaning and/or repairs required to the vehicle as a consequence of any act or omissions of the passengers. You acknowledge that it is at the sole discretion of All Stars Limousines as to who it elects to undertake any such repairs or additional cleaning.

13/ To the extent permitted by law, you are liable for all loss and damage All Stars Limousines may incur due to any act of the passengers for any period in which the vehicle cannot be used as a consequence of such act, to be determined by All Stars Limousines in its absolute discretion.

14/ You expressly authorise All Stars Limousines to deduct, without prior notice to you, any amounts that become due and payable to All Stars Limousines under these terms and conditions from the credit card nominated on the respective booking form.

15/ The booking form and these terms and conditions are the entire agreement between the parties. Any prior communications, representations or agreements in relation to the subject matter of these terms and conditions are merged in and superseded by this document. From time to time the driver or other representative of All Stars Limousines may impose extra terms or conditions on hire. These extra terms and conditions become part of this agreement and in the event of inconsistency, the terms and conditions set out in this document will prevail.

16/ All Stars Limousines reserve the right to amend the terms and conditions at any time without prior notice to you. In the event that these terms and conditions are varied by All Stars Limousines, the revised terms and conditions will apply on and from the date of variation.



17/ This agreement must not be modified, partially or fully suspended or interpreted in part in any way without the consent in writing of All Stars Limousines Sydney Pty Ltd. By paying a deposit or a booking in full you are accepting these terms and conditions as set out above in their entirety.
